# **GREEN PHILOSOPY**

Corbetta Salvatore has been producing chairs, tables and furniture for the contract market for 60 years.

Environmental sustainability is an important value from which product design, management and production depend. We focus our attention to the use of materials, we try to reduce the raw materials consumption, to rationalize the resources, to re-use and re-cycle wastes and last but not least to control emission to atmosphere.

In accordance with legislation, daily control as well as ongoing update of the productive and energetic machinery allow optimizing materials consumption and waste. We take particular care of production waste; the packaging is studied to be easily recycled and the products are moved and transported in order to have less environmental impact. The personnel is constantly trained and informed about our environmental policy in order to be conscious of our green vision and to be an active part in the environmental program.

#### DESIGN

Every product is designed to be environmental sustainable. The materials shall be recyclable and the design shall allow products assembling and disassembling. This approach increases the lifecycle of our products and allows an easy recycle.

### **METAL**

An important part of Corbetta Salvatore's production focuses on metal: steel, stainless steel and aluminum. Metal pipes and profiles are cut, bend and welded. During this process the waste is collected and stored in dedicated boxes that are periodically collected by specialized companies for the correct disposal according to the legislation. Pipes and profiles are chrome plated or painted (power coating) by external providers.

# **PLASTIC**

Corbetta Salvatore produces the majority of plastic components included in its products by mold injection.

High- recyclable techno polymers (100%) sourced inside the European Community in accordance with the current legislation are used to produce the plastic items.

No chemical additives are used in the production process. Wastes are re-used or, in case this is impossible, they are stored in dedicated boxes and collected by specialized companies for the correct disposal according to the legislation.

# WOOD

The wood items/ components are produced according to the European Legislation for what concerns the formal-dehyde emission. Corbetta Salvatore uses raw material coming only from certified sources. Wastes are stored in dedicated boxes and picked up by specialized companies for the correct disposal according to the legislation.

## **FABRIC**

Corbetta Salvatore uses non-toxic and non-allergenic fabric and leather. Wastes are separated, collected in dedicated boxes and picked up by specialized companies for the correct disposal according to the legislation.

## **PACKAGING**

Packaging is design and realized with recycled materials such as paper and cardboard. The packaging is optimized to reduce transport volume, costs, and environmental impacts.
