### GENERAL INFORMATION

Sedex has been producing chairs, tables and other furniture for the contract market since its historical foundation in the year 1979. Environmental sustainability is an important value for the company. We focus our attention to the use of materials, we try to reduce the raw materials consumption to rationalize the resources, to re-use and re-cycle wastes as much as possible and, last but not least, to control emission in atmosphere

In accordance with laws, recurring control as well as ongoing update of the productive and energetic machinery allow optimizing resources and materials as well as reduce wastes and leaks. We take particular care of production waste : the packaging is studied to be easy recycled and the products are moved and transported in order to have less environmental impact. Workers are constantly trained and informed about the environmental policy in order to be conscious of the company's green vision and to be active part in the environmental program

### DESIGN

Every product is designed to be environmental sustainable. The materials shall be recyclable and the design shall allow assembling and disassembling. This approach increases lifecycle of the product and allows as easy recycle

### WOOD

An important part of Sedex's production concerns wooden materials and its derived products. Raw materials come from certified sources, items and its components are produced according to the european legislation for what relate the formaldehyde emission. Wastes are divided and stored in dedicated boxes that are periodically emptied and collected by specialized companies for the correct disposal according to legislation

### VARNISHES

The paints for wood are formulated with respect of the human being and nature, for the benefit of anyone who get in touch with them. The application takes place in full compliance with current regulation about health and safety on the workplace, with constant monitoring of emission in the atmosphere in order to reduce their quantity and to ensure they fall within the parameters of the law. Paint residues, as hazardous waste, are separate by kind and category, carefully stored in dedicated space and then entrusted to companies specifically authorized for appropriate disposal

### FABRICS AND COVERINGS

Sedex uses non-toxic and non-allergenic fabrics and faux leathers. Wastes are separated, stored in dedicated boxes and disposed according to the legislation

### PADDINGS

The upholsteries are realized in flexible polyurethane foam that does not contain prohibited substances and meet the requirements of national and international regulations in force. The wastes are re-cycled as much as possible, otherwise they are separated, stored in dedicated boxes and disposed according to the legislation

### PACKAGING

Packagings are realized as much as possible with recycled paper, cardboard and wood. They are optimized to reduce transport volume, costs and environmental impact

### METAL AND PLASTIC

Metal parts are in steel, stainless steel and aluminium. They are powdercoated or chromed. Both metal parts and plastics parts are supplied by external providers. Wastes are stored in dedicated boxes and collected by specialized companies for the correct disposal
